

**SUMMARY ANNUAL REPORT**  
**for**  
**BROTHERHOOD OF LOCOMOTIVE ENGINEERS AND TRAINMEN**  
**DISABILITY AND WELFARE BENEFIT TRUST FUND**

This is a summary of the annual report for the Brotherhood of Locomotive Engineers and Trainmen Disability and Welfare Benefit Trust Fund, 30-0262584/501, for 01/01/2019 through 12/31/2019. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has a contract with Sun Life Assurance Company of Canada to pay certain claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2019 were \$5,925,046.

*Basic Financial Statement*

The value of plan assets, after subtracting liabilities of the plan, was \$14,498,751 as of 12/31/2019, compared to \$12,738,322 as of 01/01/2019. During the plan year the plan experienced an increase in its net assets of \$1,760,429. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$8,157,498, including employer contributions of \$5,773,840, employee contributions of \$783,760, gains of \$151,521 from the sale of assets, earnings from investments of \$1,445,528, and other income of \$2,849. Plan expenses were \$6,397,069. These expenses included \$472,023 in administrative expenses and \$5,925,046 to insurance carriers for the provision of benefits.

The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.
